Established in 1996, the Indian Institute of Management, Indore, is the sixth addition to the prestigious IIM family of management schools. Indore was chosen to host the school to give an impetus to management education in Central India and since then, the institute has pioneered various initiatives in the field of management interfacing with the industry, government sectors, and PSUs. The essence of management, IIM Indore believes, lies in managing one's own ambitions and forging ahead consciously. "A Strong theoretical foundation is the basis of good corporate practice". IIM Indore offers a range of programmes such as the PGP Programme, IPM Programme (Integrated five year Programme), EPGP Programme (for experienced professionals), PGPMX Programme (for working executives, from Mumbai campus), GMPE Programme (for working executives, from Indore campus), besides various management development programmes on both online and physical mode.

The DPM Programme and the EDPM Programme are the two doctoral programmes of the institute.

Doctoral Programme in Management at IIM Indore

The Doctoral Programme in Management (DPM) at IIMI is a unique doctoral programme which is designed to provide a comprehensive research knowledge to the doctoral candidates. The objective of the programme is two-fold: to enable the participants to master the relevant methodological tools of management research, and the advancement of the current body of management knowledge. The DPM programme offers prospects of a career within academia or in research-positions outside the academic world. The programme's rigorous curriculum provides ample training for an academic career and gives participants the opportunity to further their research goals, with specialization in various areas of management.

The DPM at IIM Indore involves rigorous coursework in all functional areas of management. The participants gain understanding in the functional areas of management. This is followed by advanced level courses in the area of specialization. The doctoral course provides a grounding in both classical and contemporary literature in their research domain. Participants also undergo advanced courses in research methods which prepares them for their dissertation. The participants are expected to demonstrate competencies in their chosen area by clearing a comprehensive examination at the end of the doctoral level coursework.

After successfully clearing the comprehensive examination the participants are ready to embark upon their own journey of knowledge creation. They are assisted in their research by a Thesis Advisory Committee that comprises faculty members from the academic area. The institute provides a best-in-class research facility and access to a wide range of academic and business databases, high-end technology, and excellent library infrastructure. The institute supports the participants through generous grants to attend conferences in India and abroad, and thereby enables them to seek feedback from peer groups and the academic fraternities around them.



Admission Process for DPM 2024

The candidates who satisfy the academic eligibility criteria (see below) can submit their application online. Candidates will be shortlisted based on their academic eligibility and acceptable standard test scores. The shortlisted candidates will be invited for Personal Interview (PI), to be conducted by IIM Indore during April 13-14, 2024. The successful candidates will be made an offer to join the programme tentatively scheduled to start in **July**, **2024**.

All matters pertaining to admission into the DPM at IIM Indore is governed by the decisions taken by the Admissions Committee. Application Procedure is available on the website

- Strategic Management (Strategic Management, International Business and Entrepreneurship)

Eligibility

Candidates must have:

Master's degree in any discipline with at least 60 percent aggregate marks or equivalent grade point average.

(OR)

Postgraduate Diploma (2 years) with at least 60 percent aggregate marks or equivalent grade point average.

(OR)

Professional qualifications CA, ICWA, CS with at least 50 percent aggregate marks.

(OR)

A five year integrated Master's degree program in any discipline, with at least 60 percent aggregate marks or equivalent grade point average.

(OR)

First Class/ equivalent Bachelor's degree (4 year/8 semesters).

Note:

- In addition to the above academic eligibility, minimum 60 percent marks in Secondary (Class X) and Senior Secondary (Class XII) is required.
- 2. Five percent Marks relaxation is given to SC, ST and PwD candidates.

Acceptable Standard Test Scores

Candidates require a standard test score, from any one of the acceptable tests for the area (s) of specialization they are applying to, as shown in the following table:

The validity of the CAT and the other standard test scores are given in the following table. Note that the scores should be valid on the deadline for submission of the application form.

CAT - 5 years

GRE - 5 years

GMAT - 5 years

GATE - 3 years

JRF - 3 years

Online GMAT/GRE (Take home) exam scores are not valid. Only test centre-based GMAT/GRE scores are valid.

Exemptions from the above tests would be given to candidates who have an MBA or equivalent from any of the IIMs. Candidates who graduated in 2019, or thereafter will be exempted.

IIM Indore will communicate the dates to short listed candidates. The institute may also choose to conduct this stage through an online mode.

Reservation norms

As per the Government of India requirement, 27% of the seats are reserved for Other Backward Classes candidates belonging to the "Non-Creamy" layer (NC-OBC), 15% for Scheduled Caste (SC), 7.5% for Scheduled Tribe (ST) candidates, 10% for students from Economically Weaker Sections (EWS) and 5% for Persons with Benchmark Disabilities (PWD).

Commitment Fee

Selected candidates shall be required to deposit a commitment fee of Rs. 75,000/- (Rupees Seventy Five Thousand only). This fee has to be paid at the time of acceptance of the offer letter by the selected candidate and is to be made vide an online bank transfer.


An amount of Rs. 50,000/- out of Rs. 75,000/- (commitment fee) deposited by DPM students shall be retained till completion of the programme and refund shall be considered in the following manner.

Refund of Rs.25,000/- after completion of Term-II

Refund of Rs.50,000/- after submission of No Dues/ Clearance form.

Financial Support

- The DPM candidates are provided a fellowship grant/ stipend of Rs. 40,000/- (Rupees Forty Thousand only) per month during their course work (Term-I, II, III, IV and V) and Rs 45,000/- (Rupees Forty Five Thousand only) per month after clearing the area comprehensive examination as per norms. The maximum duration for which they can get stipend would be 57 months (4 years and 9 months).
- A Research Development Grant of Rs. 37,500/-(Rupees Thirty Five Thousand Five Hundred only) per annum, for 4 years is also provided to DPM students to support their research efforts and is subject to the norms of the programme.
- The institute subsidizes expenses for presenting papers in national conferences, subject to a ceiling of Rs. 30,000/- per year with a provision that from second year onwards for attending n number of conferences per year subject to a cap of Rs. 30,000/- per year.
- For international conferences, the institute subsidizes expenses subject to a ceiling of Rs. Two lakhs with a provision to attend a maximum of two international conferences plus an international doctoral colloquium or an international professional development workshop during the entire period of the programme but not beyond five years.



Waivers for PGP courses

Candidates who wish to apply for waiver from first year PGP coursework or any other courses would need to make an application to the Chair, DPM at the time of submission of their acceptance letter for provisional admission into the DPM.

Following candidates are eligible to apply for waiver for the PGP course of the Doctoral Programme in Management:

- 1. Pursued full time, residential, non-online, in person PGP/MBA from an IIM in last three years provided the candidate has obtained in the first year of the above degree/diploma a minimum grade point equivalent to 3.00 out of 4.33, with no Fs and not more than two Ds.
- 2. Candidates who have completed similar program of other universities or Business Schools are eligible to apply for exemption of foundation course, provided they satisfy the following conditions:
 - The candidate should have completed a full-time, two-year MBA degree, two-year PG Diploma in Management or one-year PGPX, one-year PGP-PMP (or equivalent) in Management from any recognized and reputed University/Business School/Institution.
 - The candidate should have obtained in the first year of the above degree/diploma a minimum average grade point equivalent to IIMI's 3.00 out of 4.33, with no Fs and not more than two Ds.
- 3. The candidates should have obtained the qualifying degree or diploma, not more than three years ago with respect to the beginning of the first term of the DPM programme into which she/he is seeking admission. However, exceptions may be made to this by the DPM Executive committee on a case by case basis.
- 4. The granting of the waiver is not automatic. After receipt of offer letter, the selected candidate if requires a waiver needs to make an application to the Chair, DPM at the time of submission of his/her acceptance letter for provisional admission into the DPM, beyond which no request shall be accepted.

The final decision related to the waiver is made by the DPM Executive Council (DPM EC) on a case-to-case basis by taking into account all relevant factors, including:

- The quality and content of the program (MBA/PGDM) undergone by the candidate.
- The performance of the candidate in the programme.
- Inputs from the Area
- The DPM EC, on applying its criteria, can grant full, partial, or no waiver to the candidate.
- The decision of the DPM EC shall be final and binding

Awards and incentives

In order to encourage DPM participants to publish papers in reputed category of journals, there is an attractive incentive structure where the students are rewarded for publications in reputed journals. The institute also gives an annual award to the best doctoral candidate that carries a substantial cash component.

Best Doctoral Student Award

The Best Doctoral Student Award is conferred on deserving graduating research scholar (DPM).

The award carries a cash prize of Rs. 50,000/- (Rupees Fifty Thousand only) and a Citation/Certificate.

Accommodation & office space

The Doctoral Programme of IIMI is fully residential and all the DPM participants are required to stay in the Hostel unless exempted. Bachelor accommodation is provided to DPM participants, however, limited married accommodation is also available for the participants and their spouses. All the rooms in the Hostel have direct computer connectivity to the main LAN. Dedicated mess facilities and basic medical and entertainment facilities are also available.

Office space is available to almost all the candidates in a dedicated space equipped with LAN connection and wifi.



Sports Facilities

IIM Indore has state-of-the- art Sports Complex, having the best sports facilities for both indoor as well as outdoor sports. The Institute has been availing services of experienced certified fitness instructors who bring a wide range of expertise to the Fitness Centre. The fitness trainers provide cardiovascular training, strength training, flexibility training, yoga and aerobics training. They also provide personalized training schedules catering to the goals and needs of an individual. The institute has a fully functional Olympic size swimming pool with facilities for Steam and sauna bath. Qualified and experienced swimming instructors plan and develop swimming programmes to ensure maximum benefit to the IIM Indore community.

Cultural Life

The institute located on top of a hill provides a scenic setting to the campus and plays host to a rich cultural setting. The students across various programmes come together to celebrate various cultural festivals and also enjoys various activities together. The institute has two huge auditoriums and another open auditorium that hosts various activities. Students on a weekend can often be seen enjoying a movie played in the auditorium.
